8.2 The Contractor agrees to transfer all intellectual property rights arising from the work to the Client.

9. Confidentiality

9.1 The Contractor agrees to keep confidential all information received from the Client during the performance of the work.

9.2 This confidentiality obligation shall survive the termination of this agreement.

10. Non-Competition and Non-Solicitation

10.1 During this agreement and for [specify period] after its termination, the Contractor agrees not to:

- Engage in business competing with the Client

- Solicit the Client's customers or employees

11. Termination
